This Privacy Policy explains how we collect, use, store, and protect personal information.

By using the Portal or providing your personal information, you consent to the practices described in this Privacy Policy.

1. Information We Collect

We may collect the following types of information:

1.1 Personal Information

- Student name, age, date of birth
- Parent/guardian name and contact details
- Phone number, email address
- Home address
- Emergency contacts

1.2 Educational Information

- Program enrollment
- Class schedules
- Attendance records
- Teacher notes as required for instruction

1.3 Payment & Transaction Information

- Payment details (processed through secure third-party systems)
- Billing history
- Subscription or tuition records

SEA does **not** store full credit card numbers or bank credentials.

2. How We Use Your Information

We may use collected information to:

We collect information under:

- Legal obligations or safety requirements

For minors, consent is provided by a parent or legal guardian.

4. Sharing of Information

Personal information may be shared only with:

4.1 Service Providers (Third Parties)

- **WIX** (hosting and CRM)
- Payment processors (Stripe, PayPal, WIX Payments, etc.)
- Communication services (Zoom Phone, SMS platforms, email tools)
- Scheduling systems
- Security or monitoring tools

These providers use data solely to support SEA operations.

4.2 Legal Requirements

Information may be disclosed when necessary to:

- Comply with state or federal law
- Respond to lawful requests
- Protect student safety
- Prevent fraud or unauthorized use

SEA never sells or trades personal information.

5. SMS, Email & Communication Consent

By submitting your contact information:

- You consent to receiving **operational messages** (schedule updates, billing alerts, lesson reminders)
- Marketing messages are optional and require opt-in
- You may **opt-out of SMS** at any time by replying **STOP**
- SEA's messaging complies with **10DLC regulations**
- Email communications include unsubscribe options

Operational messages may remain necessary for enrolled students.

7. Data Storage & Security

SEA uses industry-standard protections, including:

- WIX SSL encryption
- Access-controlled CRM
- Encrypted databases
- Secure payment processing
- Limited administrative access

We take reasonable measures to prevent:

- unauthorized access
- data loss
- misuse of personal information

8. Children's Privacy

SEA collects student information only with **parent or guardian consent**.

We follow best practices aligned with:

- **COPPA expectations** (for minors under 13)
- Educational privacy standards similar to **FERPA** (not legally required, but applied as best practice)

Children cannot create accounts on their own.

9. Your Rights

Parents/students may request at any time:

- Access to personal data
 - Correction of inaccurate information
 - Removal of data (subject to legal/operational limits)
